



Total Command 10-Year Annuity

Total Command 10 is a single premium tax-deferred fixed annuity issued by Standard Life Insurance Company of Indiana. It gives policyholders a unique level of control over aspects of their contract that are standardized on most annuities, allowing you to tailor the product to suit your personal needs and priorities. Interest rates are guaranteed for the full 10-year Guarantee Period and will be renewed at the base rate being offered to new Total Command customers at that time. Taxes on accumulated interest are deferred until money is withdrawn from the annuity.

Guarantee Period – 10 years

Cash Surrender Value – Total Command 10 can be surrendered at any time for an amount equal to the Account Value subject to Surrender Charge and a Market Value Adjustment.

Surrender Charges – The Surrender Charge is listed below.

 \$10,000 - \$250,000, Non-qualified, without prior approval.

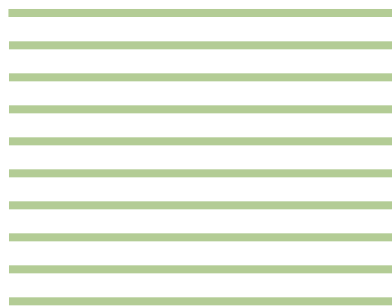
